Final Exam:	Scheduled during the examination period, the 2-hour exam will have multiple choice true/false questions and short- answer questions plus one integrative problem. Calculators are permitted. Given the nature of the course, material is cumulative but a larger focus will be on material covered since the mid-term test.			

### Course Evaluation and Missed Quizzes/Tests/Assignments:

Assignments (i.e., case study assignment) are due as stated in the course syllabus and will not be accepted late, except under medical or other compassionate circumstances. Submitting a late assignment without appropriate documentation will result in a zero (0) grade. A missed midterm examination, without appropriate documentation will result in a zero (0) grade. Acceptable reasons include hospital stays, serious illness, family emergencies (like serious accidents, illness or death) or similar circumstances.
