My Course Description

The course is designed to achieve two primary objectives. The first objective is to introduce the student to basic critical thinking. Some of the skills to be taught are: 1) identifying Claims, Issues, and Arguments; 2) understanding & identifying premise and conclusion; 3) differentiating and understanding inductive and deductive arguments; 4) Persuasion techniques; 5) Fallacies and the principle of charity; and others. A good critic can reconstruct the best version of the argument underappraisal by constructing chains
