This course will explore the theory and practice of leadership training in how physical activity affects resilience towards stress. Focused on a Mentor-Protégé model, students will be partnered with first-year students to provide guidance in physical activity.

Course topics include leadership training, reflective practice, relationship management, and conflict management.

Prerequisite(s): Registration in the School of Kinesiology; successful completion of

Kinesiology 1070A/B and Kinesiology 1080A/B.

Course Description:

A course that examines the historical and contemporary approaches to leadership and provides students with the opportunities to apply the concepts in their personal and professional lives. Several leadership theories and applications will be reviewed and analyzed. Reflection activities and assignments will be integrated into the course to ensure deep learning and application.

Using the knowledge and skills gained in first and second year, upper year Kinesiology students will be mentors for students in first year (). The primary focus of the mentor experience is to act as guides to direct mentee participation in regular leadership and physical activities throughout the school year. In addition, there will be significant opportunity to mentor in many areas germane to their first-year experience.


Plagiarism

may, on occasion, be impaired by extenuating circumstances that are medical or compassionate in nature. These extenuating circumstances may be acute (short term), or it may be chronic (long term), or chronic with acute episodes. Most forms of academic consideration require documentation, and this documentation is to be submitted to academic counsellors within five (5) business days of their return to


