Prerequisite: Ontario Grade 11 French (Core, Extended or Immersion) or equivalent, French 1002 or French 1003 or French 1003B or permission of the Department of French Studies.

Antirequisite: The former French 1101, French 1010, Ontario Grade 12 French (Core, Extended or Immersion) or equivalent.

Unless you have either the requisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. COURSE OBJECTIVES

By the end of the course, students will be expected to:

be able to recognise and identify most parts of speech.

understand sentences and frequently used expressions related to areas of most immediate relevance (e.g. personal and family information, shopping, local geography, employment). communicate in simple and routine tasks requiring a simple and direct exchange of information on familiar and routine matters.

describe in simple terms aspects of his/her background, immediate environment and matters in areas of immediate need.

DESCRIPTION OF PROGRAM:

FOUR CHAPTER TESTS - 30 minutes (25%)

There will be 4 Chapter Tests. Tests will concentrate on the most recently covered material, but they are cumulative, which means material from past chapters can be used in subsequent Chapter Tests. (Detailed calendar will be provided through the Owl site)

A Test Outline will be available before each Chapter Test.

ORAL TEST - 10 minutes (5%)

An Oral Test given at the end of the term. Each student will set up a 10-minute interview with the instructor. The Oral Test will include reading, listening and speaking components.

COMPOSITION (5%)

A 200 words Composition, Subject will be announced 2 weeks before (early November).

LAB HOUR (15%)

The contents of the language laboratory periods will be oriented towards oral comprehension (5%) and oral production (5%). These activities will be presented through different approaches: games, role-play, simulations, oral presentations, etc. Attendance and participation during the laboratory classes will be required for all participants (5%).
