Course Objectives

This course equips students with writing tools for the digital age. Topics include copyright and remix culture, neuroscience and the impact of online reading, collaborative writing with humans and artificial intelligence, and how to craft compelling content for a variety of online mediums and platforms, including social media and websites.

Explore the Neuroscience of Online Reading

Critically assess the effects of digital reading on comprehension, attention, and memory, incorporating insights from neuroscientific research.

Craft Persuasive and Compelling Digital Content

Create engaging and effective content tailored to diverse digital platforms, with attention to audience, purpose, and medium.

1) Quality of Posting

All posts on the Discussion Board must

Contribute something meaningful to the board.

Support your opinion with sufficient reasons or evidence.

Display good grammar and organization.

Postings should not

Contain disrespectful, insulting, or offensive language. Be excessively long (more than one screen length) or excessively short. Be unrelated to the forum topic. Only say things like "I agree with you" or "Nice comment!" that do not contribute substantially to the discussion.

The use of racist or any language that works against the values of Equity, Diversity, and Inclusion will not be tolerated.

Scholastic Offences, including Plagiarism
